COMMISSIONER REPORTS – August 2, 2023

Beach Commissioner Report – Jim Horton

The new paver pathway was completed in July. Many thanks to volunteers Don and Patty Mayer for a job well done.

Bridge Commissioner Report – report submitted by Dan Downey

1. Spring and Summer 2023 was marked by:

- Painting the upper bridge rail with a cold-galvanizing product turned out good
- Work party to rebuild the concrete planters and their irrigation system looks great

- Overhaul the bridge Edison light strings, and regulate them with photocell switches - Members have varying opinions about this type of lighting for the bridge. Other options are rail-mounted 110V LED downward-facing floods (not the dim 12V landscape "night lights" currently mounted on the rail), or quaint streetlight-like overhead fixtures on poles.

Dock Commissioner Report – Jim Horton

Our dock piling and pier replacement project continues to be under budget and ahead of schedule. We received word today, July 19 that our Mason County Building Permit was approved. Cost of the building permit and all reviewing fees and surcharges totaled \$4,380. Our members approved a Phase I budget for:

**Monitoring cost depends on the number of pile driving days (1 or 2).

At this time we do not expect any expenditures for contingencies.

Phase II (construction) is scheduled for mid to late September. The exact timing depends on tides. Pile driving is only expected to take a day, possibly two. Our pier is being fabricated in Marine Floats Tacoma workshop and will be barged to Treasure Island, lifted and bolted into place. Onsite construction is expected to be a week or less.

We are going to spend some contingency money to replace the existing blue fence. It will be a cable type fence that will not detract from our view and will also prevent a small child from getting underneath, or through, the fence.

I have talked will three contractors. They are working on their bids. quotes. Hopefully we will have new pilings, pier and fence before Thanksgiving.

Roads Commissioner Report – report submitted by Dan Downey

1. Road system on the Island is operational. Cleaning and preventative maintenance is year round. Consideration of contracted cleaning and preventative maintenance of the roads by a service company is underway by the Board.

2. Plans underway to:

- Grade and fill pot holes on inner utility road by Dave Parker and his son, TJ. Other consideration is to control dust on this road with either a cellulose product, ligin, which binds with the dust and lowers its mobility, or a ground-up asphalt product (<u>not</u> hot asphalt paving) with embeds to the existing dirt / gravel surface and slows pot hole recurrence.

- General repair of cracks and deterioration over the entire road with repair / replacement of severe crumbling, or applying hot tar to seal simple cracks.

- Finally, the north and east parts of the culvert drain system need cleaning and restoration of a deep, continuous culvert to carry surface runoff to the catch basins that route stormwater to the east side mid-island drain to the Sound.

Water Commissioner Report – Sarah Voss

June and July have been high water usage months all over the state. We are no exception. Fortunately, TICC water system has stayed at standard pressure and has maintained the quality that we have come to expect. As members of a private water system, we all have a responsibility to be mindful of our quality resource and to practice water conservation whenever is possible. The Washington State Dept of Heath has a division called Office of Drinking Water. ODW puts out a monthly newsletter with tips, observations, updates on regs and classes on just about anything relating to water. You can find a lot of useful information on that website.

June was flushing month for fire hydrants and standpipes, and yes, we have a working fire hydrant system. It is not Mason County Fire Dept first line of defense on the island, but it is a charged and working system if needed. After that flushing many of us experienced surging and cloudy water. Those were not a result of the fire system flush. Our domestic water system had a couple of electronic fails with wells #2 and #3. Those have been addressed and repaired by Northwest Water Systems. I called our water system manager and reported there was still cloudy water post repair. I know that the cloudiness is just extra oxygen and it dissipates in less than 30 seconds. It is not harmful to drink at all. NWWS field manager said "You would be surprised at the amount of water systems in Washington with that concern this year, and with no water system distribution failures. Possibly high temps, lack of rain, there is no finite explanation." NWWS manager said he would review the video, pictures and notes from his technician and continue to monitor TICC water system. Please if you have concerns, see water

I read an article in the AARP Bulletin called "The Surging Cost of Water". It made some good points that TICC members need to be cognitive of. Did you know the average American family uses more than 400 gallons of water a day, with 70 percent of that for indoor uses. Can you imagine what we pushed through our system over this last 4th of July holiday? Our water system infrastructure is over 50+ years old. Such age leads to breakdowns, outages, main line breaks, which lead to maintenance, materials, and labor costs that are only on the rise. We have all been relying on a system that is sort of "out of sight, out of mind". Conservation, being water wise and understanding that the financial impact of suppling quality drinking water to our community is entrusted to all who enjoy Treasure Island.
